



Artis Top Gun Membawa Tuntutan Terhadap Paramount Karena Penggunaan Likeness Maverick tanpa Izin

Description

Barry Tubb is taking legal action against Paramount Pictures over the unauthorized use of his likeness in the film *Top Gun: Maverick*.
